**Ballot Placement:** First day filers (2/27/2018) selected a number by random drawing to determine their placement on the August 7, 2018 primary ballot. After the first day, candidates are placed on the ballot in the order in which they file for office.

**Note:** Candidates for the office of committeeman or committeewoman will only be placed on the August 7, 2018 primary ballot if more than one candidate files for the same precinct position for the same political party.
