PROPOSITION I

Shall the school board of Cape Girardeau County R-V be authorized to increase the tax levy for Incidental Fund by 70¢ on the one hundred dollars assessed valuation? If this proposition is approved by the voters the total levy of the school district will be \$3.75 per one hundred dollars of assessed valuation.

The current levy including Debt Service is \$3.95. This proposition, if approved by the voters, will increase the total levy by 70¢ to \$4.65.


